James Glover gave the Architectural Review Committee (ARC) report. Letters were mailed to neighbors recently to identifying areas on property to improve. James also reported that the architectural committee prior to the beginning of work should review any home improvements. Other business included an announcement that Chistine Lewis will be putting out pine straw at the front entrance the Saturday before Easter, or April 2nd at 9:30am. Anyone willing to help will be welcomed and appreciated. Also noted was that police are out periodically in the neighborhood monitoring turn and stop sign regulations.
